The privilege of driving on campus is not one to be lightly assumed. The safety of others and the security of the school and personal property require the following regulations to be observed by all drivers – students, parents, faculty, staff and visitors. I understand and agree with the following:

1. All cars driven to school by students must be registered in the main office. A parking permit is issued for all campus-registered cars and must be visibly displayed on the rear view mirror, while on campus. **Students driving another car for a day or two must advise the front office; longer than that will necessitate the car being registered.**
2. The car herein described is, and will be, covered by the owner's comprehensive and liability insurance throughout the entire period of use during the current school year. Proof of insurance must accompany the car registration form.
3. Only properly licensed drivers may operate a motor vehicle on campus; all vehicles must be properly registered by the State Department of Motor Vehicles. Allowing other students to drive your car on campus is prohibited.
4. I give permission for search and seizure of my car if there is reasonable suspicion.
5. The speed limit on 109 Ave. is 15 MPH and on campus is 5 MPH. All pertinent traffic rules are to be observed on campus and driving to and from school; violations will lead to loss of campus driving and parking privileges.
6. Once cars are parked on campus after 7:45 a.m., they are off limits to all students, including the driver, until dismissal time. No students are to be in the parking lot during the school day without specific written permission from the office.
7. **Discipline Procedures for:**
 - a. parking in the pick-up/drop area
 - b. not displaying your decal while on campus
 - c. improperly parking your vehicle
 - d. or other minor violation so deemed by the Administration

1. **The first and second parking violations: lunch detention**
2. **The third violation and thereafter, will result in disciplinary notices**

8. Discipline Procedure for more serious violations

- a. allowing other students to drive your car
- b. driving on the sidewalks
- c. speeding on campus
- d. reckless driving on campus
- e. or other serious violations so deemed by the Administration

Immediate suspension of driving privileges on MCS campus for 2 weeks and a fine of \$10.00 per occurrence. Should there be a continued pattern of serious violations; driving privileges will be suspended for the rest of the year.

In signing this form we agree to all the terms of this agreement and will support the school administration in all decisions regarding the use of this vehicle for transportation to school, and to and from school functions. Furthermore, I give the school the right to inspect vehicles at the school administration's discretion when there is a reasonable basis to believe that the vehicle contains illegal substances or other material or items that violate school rules.
